DETAILED INFORMATION

ELIGIBILITY:

Under this visa category, any overseas business person can expand his/her existing business in the UK in the UK by opening a branch or Franchise thereof on some terms & conditions:

FEATURES:

- All Business Categories;
- Flexible Investment Options;
- No English Language Assessment;
- No upper age limit;
- No Minimum Stay;
- Spouse and dependent children under 18 years of age allowed;
- 2-3 Families can move under this visa

Actually, there are 02 phases of this visa category which are as under:

01ST PHASE:

1. Initial Assessment;
2. Preparation / Approval of Business Expansion Plan;
3. UK Company Formation;
4. UK Company Licence;

DOCUMENTS CHECKLIST FOR VISA PROCESSING:

- **Valid Passport:** Ensure for submission of a current passport which must be valid for the duration of intended stay in the UK.
- **Certificate of Sponsorship (CoS):** UK-based employer must issue a CoS, which is a reference number that will be to provide in the visa application.
- **UK Visa Application Form:** Complete the online application form accurately and fully.
- **Passport Photographs:** You'll need to provide recent passport-sized photographs.
- **Biometric Information:** To attend an appointment to provide your biometric information, such as fingerprints and a photograph.
- **Visa Fee:** Pay the required visa fee as per the UKVI website.
- **Proof of Financial Support:** Demonstrate to have sufficient funds to support yourself and any dependents during your stay, unless your CoS indicates your employer will cover this.
- **Bank Statements:** Provide recent bank statements showing your account balance.
- **Job Title & Annual Salary:** Provide details of job title, annual salary, & occupation code.
- **Employer Information:** Name of employer and their sponsor license number (CoS).
